Rationale

The children are to experience a broad range of artistic experiences in order to appreciate and enjoy a wide variety of art styles and techniques.

Pupils are given work that challenges their abilities and expectations.

Pupils become increasingly more confident, independent and technically able as they move up the school.

Scholarships are discussed in year 4 and portfolios are built up from year 5 onwards. Extra help is offered to scholarship pupils at lunchtimes and after school.

AIMS

- 1. To have a policy that allows for continuity, progression, breadth and balance
- 2. To have clear and concise scheme of work that is regularly reviewed
- 3. To collaborate with staff in order to create cross-curricular links
- 4. To assess, review and extend resources with a planned financial allocation
- 5. To give children the opportunity to comment on their own and each other's work
- 6. Monitor pupil's progress through the review of sketch books and other artwork
- 7. To use observational drawing as the starting point for most art work
- 8. To introduce and use a wide range of art media and techniques appropriate for the age and stage of the children
- 9. To use a variety of starting points for artwork including the work of other artists
- 10. To enhance the classroom and wider school environment with stimulating displays
- 11. To introduce and explain appropriate artistic terms and vocabulary

OBJECTIVES

- 1. Lessons to include drawing in every project, along with media that is suitable for the learning environment including but not exclusively graphite pencil, coloured pencils, felt pens, sharpies, poster paint, watercolour, acrylic paint, wax crayons/oil pastels, clay and printing ink.
- 2. Lessons to teach and incorporate a range of techniques including but not exclusively drawing from memory, imagination and observation; painting; printing; construction and assembling; collage; wax and masking tape resist; sewing; designing; use of templates; rubbing; sewing; clay modelling; slab building with clay, creating texture with clay.
- 3. Years KG to Y6 to include art appreciation including art and art styles for different times and places.
- 4. Review each lesson in order to adjust lessons appropriately
- 5. Allow time in lessons to review and refine work, either by self-reflection, peer comment or teacher input.
- 6. To change displays around the school at least once a term, but aiming to change them every half term when possible.
- 7. To work with other schools where appropriate.
- 8. Use of artistic terms and vocabulary when appropriate to the work undertaken. Display a list of artistic vocabulary and draw attention to those terms where necessary.



- 9. To offer to do cross-curricular work once a term in consultation with class teachers. The other half of term will be reserved for 'art for art's sake'.
- 10. To have an annual art show with work from all pupils.

HEALTH AND SAFETY

The Art Department will ensure as far as reasonably practicable that the health and safety of all employee and children and those who may be affected by its actions will be safe-guarded.

All efforts will be made towards ensuring that the working environment will be incident free.

This will be achieved by;

- Proper maintenance and storage of all art equipment, keeping the art room as tidy as practicable.
- Hazardous materials and equipment are kept in the store cupboard with no student access.
- Spillages are swiftly mopped up and floors are kept clear of trip and slip hazards.
- Pupils are taught to work in a safe manner, particularly when using new and unfamiliar equipment and materials.
- Staff undertake health and safety training and complete and annual risk assessment of the room.
